Licensure and Credentialing Requirements

The credentialing of professional counselors takes various forms. Credentialing itself is an umbrella term to cover such areas as state licensure, certification, and registry. Licensure is critical to one's ability to practice in any state as a professional counselor. Licensure is the government's regulatory process to protect client safety by ensuring that professionals meet minimum education and clinical training requirements. It is the student's responsibility to understand and make arrangements to meet the licensure requirements of the state in which he or she intends to practice. At this point, each state has separate licensure requirements although the ACA is working toward reciprocity. The student is encouraged to work with the faculty advisor to make necessary modifications to the plan of study in order to meet requirements if the student plans to move out of state. Some states require additional courses or clinical training that Tennessee licensure does not require.

Students should be advised that licensure laws and requirements change periodically, and they are advised to check the laws at the time they are actually pursuing licensure. Requirements written in this document are accurate at the time of publication but may not be accurate once a student graduates and is in pursuit of licensure. Lipscomb University's Master of Science in Clinical Mental Health Counseling meets the academic requirements for licensure in the state of Tennessee. Additional exams and supervised clinical activities (across 2-4 years) are required to fully meet licensure requirements.
